(A) ABOUT THE KSSFCL

Karnataka State Souharda Federal Cooperative Ltd, the first Apex Body of New generation cooperatives in India. Souharda Federal Cooperative is a quasi judicial and democratically elected self-regulatory organization of the cooperatives registered under Karnataka Souharda Sahakari Act, 1997.

(B)TERMS & CONDITIONS:-

1. The price will be inclusive of all taxes / duties and freight / handling charge. No extra charges will be paid. GST No. and Charges must be mentioned in your quotation, otherwise it may consider as rates are inclusive of GST.
2. Work may be awarded to lowest rate quoted by agency (L-1 basis) .
3. Final payment shall be on the basis of actual rate quoted in below table.
4. Price validity shall be 60 days from the date of opening.
5. reputed manufacturer or his authorized dealer submitting the proposal must registered under GST and GSTN and PAN shall be submitted by the agency/Contractor with the proposal.
6. Guarantee / Warranty shall be covered by OEM and guarantee / warrantee documents to be submitted with invoice.
7. Specification of required wall clock Model mentioned in Annexure C
8. Bidders have to submit the Authorization letter for selling of **Ajanta/Titan/Rikon/similer Brand Wall Clock**
9. Bids received without prescribed Earnest Money Deposit (EMD) and required documents shall not be considered.
10. Bidder have to submit the non-blacklisting declaration in the format (Annexure-A).

(C) MODE OF SUBMISSION

1. Tenders should be addressed to Managing Director, KSSFCL, and Bengaluru only.
2. Tender can be submitted in person on or before the due date and time specified in the tender notice. Such tenders may be dropped in the TENDER BOX kept at the reception/common area of KSSFCL Bengaluru.
3. Alternatively, the tenderer who prefers to submit the tender through post can dispatch the same through Registered Post or Courier so as to reach the above address on or before the due date and time specified in the Tender Notice. Tenders received after the due date and time, for what so ever reasons will not be considered, and the KSSFCL, will not be liable or responsible for the same.
4. Tender should be submitted in the prescribed Tender Document obtained from the Purchase department, KSSFCL Bengaluru or downloaded from KSSFCL website.

(D) EARNEST MONEY DEPOSIT & SECURITY DEPOSIT

1. Tenderer shall enclose a demand draft/pay order of any scheduled bank of Rs.20,000/- (Twenty Thousand only) in favor of Karnataka state Souharda Federal cooperative ltd payable at Bengaluru as the non-interest bearing Earnest Money Deposit. Bid without EMD shall be rejected.
2. The Earnest Money Deposit of the unsuccessful tenders will be returned, after the acceptance of the work order by successful tender, at the expense of the Tenderer within reasonable time. Earnest Money Deposit will not bear any interest thereon.
3. Cheque, Bank Guarantees will not be accepted towards EMD.
4. The Earnest Money Deposit/Security Deposit will be forfeited if: a. Successful bidder fail to supply the Wall clock, Tenderer withdraws his tender or backs out after submission of tender, tenderer fails to remit the Security Deposit @05% of supply order value.

(E) **DELIVERY:** The successful bidder should supply the wall clock within 10 days from the date of “Purchase Order”.

(F) **PAYMENT TERMS:** 100% payments shall be made after the successful safe delivery, of the order.

(G) **JURISDICTION FOR LEGAL PROCEEDING:** Suit or any legal proceedings in regard to this matter arising in any respect under this contract shall be instituted in any court in Bengaluru only.

(H) **PENALTY :** In the event of failure of the successful tenderer to make supply of wall clcok within the stipulated time, without prejudice to other remedies under the contract a

penalty equivalent to 0.5% (Half Percent) of the value of delayed goods will be levied per week with a maximum of 5% of the contract value. If requested by the tenderer, it is the discretion of the, KSSFCL Bengaluru to grant extension of time with penalty/without penalty and to purchase the stock from any other source at the prevailing market rate at the risk and responsibility of the successful tenderer and to claim any loss sustained by KSSFCL Bengaluru in the transaction from the tenderer besides forfeiting Earnest Money Deposit and Security Deposit.
